Sister Mary Louise Brink

Education has always been an important aspect of Sister Mary Louise Brink's life, as has her membership in the Sisters of Charity-Halifax.

Born in the Bronx and raised on Long Island, Sister Mary Louise attended St. Joseph's School in Babylon before entering **Seton Hall High School**. Little did she know as a student that years later she would return to the school as a teacher, and eventually become its final Principal.

After becoming a Sister of Charity, her education continued with a Bachelor's Degree from Mount Saint Vincent University in Halifax, a Master's Degree in Math Education from Adelphi University, a Master's Degree in Theology from Boston College and a Doctor of Philosophy in Systematic Theology from Fordham University.

Within the Sisters of Charity she served as First Assistant on the General Council for the Congregation from 1988-1996. In 1996 Sister Mary Louise was elected Congregational Leader serving in that position until 2002.

Having completed her term as Congregational Leader, Sister Mary Louise returned to New York and became the Associate Dean/Director of Graduate Studies at the Seminary of the Immaculate Conception in Huntington. In September 2006, Sister Mary Louise accepted her current position as Academic Dean at the Seminary.

John Schmitt Jr.

Born in Brooklyn, John Schmitt Jr. became a proud **Seton Hall High School** graduate in 1960. Pursued by Coach Howdy Myers, John decided to attend Hofstra University instead of the Merchant Marine Academy in Kings Point.

At Hofstra, John received Little All American Honors and was named Captain of the football and track teams, graduating with a Bachelors Degree in Management/Marketing with a minor in Economics.

After New York Jet coach Weeb Ewbank offered him a try out, John signed as a free agent with the team in 1964. Playing eleven seasons with the Jets, he served as their Captain, received All Pro Honors and in 1969, became a Super Bowl Champion. In his last season, he played for the Green Bay Packers, retiring in 1975.

In 1973, John and his partner, Stanley Sussman, created the PFP Corporation, offering Life Insurance, Disability Income Insurance and Critical Illness Insurance to Credit Union members across the country.

Married to his lovely wife, Joanne, for over 40 years, John has three children, John, Timothy and Jacqueline and 7 grandchildren, Lily, Sarah, Charlie, Jack, Tanner, Luke and Timothy John.

A much sought after motivational speaker, John is involved in many charitable organizations and serves on the boards of the Cerebral Palsy Center of Albertson, Big Brothers and Sisters of New York, The Heart Association, The Arthritis Foundation, Telecare, Marty Lyons Grant A Wish Foundation and Island Harvest to name just a few.
